# RECOMMENDATION(S):

That the Board of Supervisors:

- 1. Adopt the attached resolution authorizing the State of California Cannabis Equity Act Grant funding; and
- 2. Authorize the County Administrative Officer to execute the grant agreement, and any subsequent amendments, with the Governor's Office of Business and Economic Development; and
- 3. Approve the attached supplemental budget for Fiscal Year 2022-23 in Fund 1120, Budget Unit 275422 (4/5 Vote Required).

Economic Development (1120), Project Trellis Equity Fund (1120 - 275422)

#### DISCUSSION:

On March 19, 2019, your Board approved Resolution No. 19-24 adopting the Humboldt County Cannabis Local Equity Program Manual for the operation of the County of Humboldt Local Equity Program (LEP), in response to Senate Bill (SB) 1294: the California Cannabis Equity Act of 2018. The LEP Manual focuses on the support of individuals and communities in Humboldt's cannabis industry who are linked to populations or neighborhoods negatively or disproportionately impacted by cannabis criminalization. With the adoption of the LEP, your Board authorized the Economic Development Division to apply for the Bureau of Cannabis Control's (BCC) Cannabis Equity Grant (CEG) funding.

Following the BCC's initial award of \$1,338,683, the BCC released administration of the CEG funding to the Governor's Office of Business and Economic Development (GO-BIZ). Under the oversight of Go-Biz, Economic Development has received three additional awards of \$2,459,581, \$1,055,870, and \$3,429,870 respectively. Project Trellis, through Economic Development, has disbursed the above awards to the Humboldt cannabis community. On Jan. 31, 2023, Economic Development was notified by GO-BIZ of yet another award for equity funding in the amount of \$1,234,821.75 for Fiscal Year (FY) 2022-23 to FY 2023-24. These funds will be used to implement service items to the cannabis industry by direction of the approved LEP.

The grant award will increase Economic Development's Project Trellis budget unit (1120275422) by the amount of \$1,234,821.75. These funds will be disbursed through fiscal years 2022-23 and 2023-24. Funds have been included in the proposed fiscal year 2023-24 budget for 1120275422.
