**DISCUSSION:**

Pursuant to Section 9121-10 of the Humboldt County Code, the Chief Probation Officer shall provide to the Board of Supervisors a written report stating that the number of detentions that were solely based on civil immigration detainees (if any) by no later than June and December of each year. The report shall address the following issues for the time period covered the report:

A) A description of all communication received from the federal agency charged with enforcement of the federal immigration law, including but not limited to the number of civil immigration detainees, notification requests, and other types of communication

B) A description of any communications the department made to the federal agency charged with enforcement of the federal

immigration law, including but not limited to any department’s responses to inquires described herein.
