That the Board of Supervisors adopt Ordinance No. _____, relating to Section 25350.60 of Government Code, which provides that the Board of Supervisors may, by ordinance, authorize a county officer to perform any or all acts necessary to approve and accept for the county the acquisition of any interest in real property.
