DISCUSSION:

The County of Humboldt contracts with Shaw/Yoder/Antwih/Schmelzer and Lange, Inc. ("SYASL") to provide state legislative advocacy services on behalf of the county, and to advise departments on the development of the county's annual legislative platform. Staff from SYASL meet with county staff and the Board of Supervisors to review progress on the county's legislative goals and to consult on the following year's legislative platform. The legislative advocacy provided by SYASL is imperative as the staff are subject matter experts who monitor the daily happenings regarding state legislation, as well as provide critical connections to legislators, state agencies and advocacy groups to help advance the county's legislative goals.
