Bid Award Authorization Regarding Storm Damage Repair to Maple Lane (3K460) Post Mile 0.14

**RECOMMENDATION(S):**

That the Board of Supervisors:

1. Receive and file the bid proposals received for Storm Damage Repair to Maple Lane (3K460) Post Mile 0.14;
2. Award Storm Damage Repair to Maple Lane (3K460) Post Mile (PM) 0.14 to Mobley Construction dba MCI, for the total amount of \$50,340;
3. Approve the attached construction agreement;
4. Authorize the Chair of the Board to execute the attached construction agreement upon submittal of the appropriate bonds and insurance; and
5. Direct the Auditor-Controller to establish new object code 1200-321-0340 Maple Lane Storm PM 0.14 and transfer \$63,000 from 1200-321-2118 to the new object code per the attached appropriation transfer.

**SOURCE OF FUNDING:**

Humboldt County Road Fund (1200-321); Federal Emergency Management Agency; and California Office of Emergency Services

**DISCUSSION:**

On May 7, 2019, the Board of Supervisors authorized the Clerk of the Board to advertise the above-referenced project for bids. On June 4, 2019, the county received four bids for the project, which are attached hereto as Attachment 1.

The Department of Public Works recommends that the Board of Supervisors receive and file the bid proposals received for storm damage repair to Maple Lane (3K460) PM 0.14; award storm damage repair to Maple Lane (3K460) PM 0.14 to Mobley Construction dba MCI for the total amount of \$50,340; approve the attached construction agreement and authorize its execution upon submittal of the appropriate bonds and insurance; and establish new object code 1200-321-0340 Maple Lane Storm PM 0.14 and transfer \$63,000 from 1200-321-2118 to the new object code per the attached appropriation transfer.

FINANCIAL IMPACT:

This project is being funded by Federal Emergency Management Agency Disaster Funds (75 percent), California Office of Emergency Services (18.75 percent), and the Humboldt County Road Fund (6.25 percent). The engineer's cost estimate for the construction contract is \$59,015. Total project cost is estimated at \$63,000, and the estimated county portion \$3,938. Construction costs were included in fiscal year 2019-20 for Road Fund budget unit 1200321-2118 Professional Services; therefore, this project will not impact the General Fund.

STRATEGIC FRAMEWORK:

OTHER AGENCY INVOLVEMENT:

Federal Emergency Management Agency and California Office of Emergency Services

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board of Supervisors may choose not to award Storm Damage Repair to Maple Lane (3K460) PM 0.14 to Mobley Construction dba MCI. However, this alternative is not recommended because the project will replace the failed culvert using funds that would not otherwise be available to the county.
