New Access Agreement with Half Moon Pictures, LLC

RECOMMENDATION(S):

That the Board of Supervisors:

1. Approve the new access agreement with Half Moon Pictures, LLC (Attachment 1) to allow for filming of Deputy Sheriff staff while on-duty; and
2. Authorize Sheriff William Honsal to execute the Access Agreement and any subsequent amendments, extensions, or renewals with approval from County Counsel, Risk Management, and the County Administrative Office.

Legal waivers will be signed by all participating parties. The contracts and waivers have been approved by County Counsel.

The show is an opportunity to promote what it is like to work in law enforcement in Humboldt County. As the Board is aware, both Deputy Sheriff positions and Correctional Deputy positions are difficult to fill and retain. Now, more than ever, is a difficult time to promote the profession of law enforcement officers. These shows will not only show the good work being done by the Humboldt County Sheriff's Office but also to provide an opportunity for promotion of potential recruitments.
