DISCUSSION:

The Board of Supervisors is sending a letter of support to Caltrans District 1 on behalf of the City of Fortuna for their grant application to the Caltrans Reconnecting Communities Highways to Boulevards (RC-H2B). The City of Fortuna is proposing that the grant support the Kenmar Road Interchange Modernization project which embodies the improvements to the US 101 interchanges at Kenmar Road. This project will provide connectivity from the city zone to the Eel River, improve safety for bikers

and pedestrians, and reduce traffic congestion at the location.
