**DISCUSSION:**

County Code Section 211-1 provides that your Board will meet "on each Tuesday at 9:00 a.m., except for the fifth Tuesday of a

month.” During 2019, months with five Tuesdays are January, April, July and October.

In addition, the Code provides that: “The Board of Supervisors, for cause, may dispense with any regular meeting or provide a different meeting location by an order entered in its minutes.” The Board has traditionally cancelled two weeks in August for a summer break, a week in November for the Thanksgiving holiday, the weeks of the annual Rural County Representatives of California (RCRC) and California State Association of Counties (CSAC) conferences, and the last two weeks in December (winter break). Additionally, your Board has recently begun to cancel the first meeting in July due to the July 4<sup>th</sup> holiday and retained the fifth Tuesday meeting in July.

For the Board’s convenience, staff has attached a calendar showing likely Board meeting dates in 2019.
