**RECOMMENDATION(S):**  
That the Board of Supervisors:  
1. Adopt Ordinance No. \_\_\_\_, amending Section 351-6 of Chapter 1, Division 5, Title III, and Sections 352-3, 352-4, 352-56, 352-8 and 352-13 of Chapter 2, Division 5, Title III of Humboldt County Code (HCC) relating to public nuisances, abatement and penalties.

**DISCUSSION:**  
On November 19, 2019, your Board introduced the above-referenced ordinance for adoption with a directive to the Clerk of the Board to publish a pre-adoption summary of the ordinance and set the ordinance for adoption at least one week away. The recommended action will complete adoption of the ordinance and result in publication of the post adoption summary.

**FINANCIAL IMPACT:**  
The cost associated with adoption of the ordinance is covered by the General Fund. The ability to immediately impose administrative civil penalties will provide General Fund reimbursement upon

receipt of penalties.
