Elk Country RV Park Request For a Waiver Outside the Number of Allowed Licenses in the Census Tract to Obtain a Type 20 Off-Sale Alcoholic Beverage (ABC) Liquor License in the Trinidad Area (Supervisor Steve Madrone)

RECOMMENDATION(S):

That the Board of Supervisors:

1. Approve the waiver to allow for an ABC Type 20 Off-Sale liquor license as requested.

SOURCE OF FUNDING: General Fund (1100)

DISCUSSION:

Pursuant to Section 23958.4 of the Business and Professions Code the Board of Supervisors may determine if public convenience warrants the issuance of or change in an Alcohol and Beverage Control license. Elk Country RV Park has requested approval from the Board of Supervisors for a waiver outside the number of allowed licenses in the Trinidad area to obtain a Type 20, Off-Sale Liquor License.
