SUBJECT:

Resolution Rescinding Resolution Nos. 20-85 and 21-84 and Adopting an Amended Conflict of Interest Code for the County of Humboldt

RECOMMENDATION(S):

That the Board of Supervisors:

1. Adopt the attached resolution rescinding Nos. 20-85 and 21-84 and amending the current Conflict of Interest Code.

SOURCE OF FUNDING:

No funding is necessary beyond already funded staff time.

DISCUSSION:

The Political Reform Act requires that the County of Humboldt's Conflict of Interest Code be reviewed every two (2) years. The County of Humboldt's Conflict of Interest Code requires an amendment to incorporate minor modifications required by law. The Board's adoption of the attached resolution will incorporate the amendments to the Political Reform Act into the County of Humboldt's Conflict of Interest Code. The modification to Appendix B fulfills this legal requirement as well. Any positions or committees that have been deleted are stricken and any additions have been underlined.
