DISCUSSION:

The Six Rivers Running Club is planning its 51st Annual Avenue of the Giants Marathon, Half Marathon, and 10K run on May 7, 2023. The resolution authorizing road closures for the marathon is the first step in the running club's permitting process. The club is asking that the Board of Supervisors
