**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
AUTHORIZING THE SUBMITTAL OF AN APPLICATION, ACCEPTANCE OF AN
ALLOCATION OF FUNDS AND EXECUTION OF A GRANT AGREEMENT WITH
THE CALIFORNIA DEPARTMENT OF TRANSPORTATION, FOR AN AIRPORT
IMPROVEMENT PROGRAM (AIP) MATCHING GRANT.**

WHEREAS, the County of Humboldt and the Federal Aviation Administration are parties to federal AIP grant 3-06-0072-022-2026 for the Precision Path Approach Indicator Project at the Murray Field Airport; and

WHEREAS, the California Department of Transportation, pursuant to the Public Utilities Code section 21683.1, provides grants of 5% of Federal Aviation Administration grants to airports; and

WHEREAS, the California Department of Transportation requires the Board of Supervisors to adopt a resolution authorizing the submission of an application for AIP Matching grant funds;

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
HEREBY RESOLVES AS FOLLOWS:**

1. That it authorizes the Director of Aviation or designee to file an application for California Department of Transportation AIP Matching grant funds for the Murray Field Airport Precision Path Approach Indicator Project.
2. That it authorizes the Director of Aviation or designee to accept the allocation of California Department of Transportation AIP Matching funds for the Murray Field Precision Path Approach Indicator Project.
3. That it authorizes the Director of Aviation or designee to execute the California Department of Transportation AIP Matching Grant Agreement the Murray Field Airport Precision Path Approach Indicator Project.
