RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE INTERIM DIRECTOR OF AVIATION, OR A DESIGNEE THEREOF, TO EXECUTE ANY AND ALL DOCUMENTS RELATED TO UNITED STATES DEPARTMENT OF TRANSPORTATION – FEDERAL AVIATION ADMINISTRATION INFRASTRUCTURE INVESTMENT AND JOBS ACT AIRPORT INFRASTRUCTURE GRANT AGREEMENT NO. 3-06-0083-15-2026

WHEREAS, the County of Humboldt (“County”) has a need to improve the planning, safety and infrastructure for its airport system; and

WHEREAS, the Humboldt County Department of Aviation submitted a Project Application to the United States Department of Transportation – Federal Aviation Administration (“FAA”) for a grant of federal funds for the Rohnerville Airport (FOT) Runway 11/29 Rehabilitation Project; and

WHEREAS, pursuant to and for the purpose of carrying out the Title 49, United States Code (U.S.C.), Chapters 471 and 475; 49 U.S.C. §§ 40101 et seq., and 48103; FAA Reauthorization Act of 2018 (Public Law Number 115-254); the Department of Transportation Appropriations Act, 2021 (Public Law 116-260, Division L); the Consolidated Appropriations Act, 2022 (Public Law 117-103); and the representations contained in the Project Application; and in consideration of: (a) the County’s adoption and ratification of the Grant Assurances attached hereto; (b) the County’s acceptance of this offer; and (c) the benefits to accrue to the United States and the public from the accomplishment of the Project and compliance with the Grant Assurance and conditions as herein provided; the FAA has allocated funding in the amount of Three Million Six Hundred Ninety-four Thousand Eight Hundred Ninety- Five Dollars (\$3,694,895) made available through the Infrastructure Investment and Jobs Act Airport Infrastructure Grant Program to the County.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

1. The Interim Director of Aviation, or a designee thereof, is hereby authorized to conduct any and all negotiations, and enter into, execute and deliver any and all documents, including, without limitation, agreements, amendments and payment requests, required, or deemed necessary, to accept and secure an allocation of funding made available through the Infrastructure Investment and Jobs Act Airport Infrastructure Grant Program.
2. If the Interim Director of Aviation, or a designee thereof, agrees to accept funding made available through the Infrastructure Investment and Jobs Act Airport Infrastructure Grant Program, the County hereby represents and certifies that the County will only utilize these funds for any purpose for which airport revenues may be lawfully used pursuant to the FAA’s Policy and Procedures Concerning the Use of Airport Revenues.
