

**FIRST AMENDMENT  
PROFESSIONAL MEDICAL RESIDENCY AFFILIATION AGREEMENT  
BY AND BETWEEN  
COUNTY OF HUMBOLDT  
AND  
ST. JOSEPH HEALTH NORTHERN CALIFORNIA, LLC  
FOR FISCAL YEARS 2022-2023 THROUGH 2025-2026**

This First Amendment to the Professional Medical Residency Affiliation Agreement dated March 27, 2023, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and St. Joseph Health Northern California, LLC, a California limited liability company, doing business as Providence St. Joseph Hospital of Eureka, hereinafter referred to as “HOSPITAL,” is entered into this \_\_\_\_ day of \_\_\_\_\_, 2024.

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Behavioral Health, desired to make its staff and facilities available to medical residents and faculty participating in HOSPITAL’s family medicine residency program; and

WHEREAS, on March 27, 2023, COUNTY and HOSPITAL entered into a Professional Medical Residency Affiliation Agreement regarding COUNTY’s participation in HOSPITAL’s family medicine residency program; and

WHEREAS, COUNTY and HOSPITAL now desire to amend certain provisions of the Professional Medical Residency Affiliation Agreement in order to extend the term thereof.

NOW THEREFORE, the parties mutually agree as follows:

1. The first paragraph of the Professional Medical Residency Affiliation Agreement is hereby amended to read as follows:

This Agreement, entered into this 27<sup>th</sup> day of March, 2023, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and St. Joseph Health Northern California, LLC, a California limited liability company, doing business as Providence St. Joseph Hospital of Eureka, hereinafter referred to as “HOSPITAL,” is made upon the following considerations:

2. Section 7 – Term of the Professional Medical Residency Affiliation Agreement is hereby amended to read as follows:

7. TERM:

This Agreement shall begin on March 27, 2023 and shall remain in full force and effect until June 30, 2026, unless extended by a valid amendment hereto or sooner terminated as set forth herein.

3. Except as modified herein, the Professional Medical Residency Affiliation Agreement dated March 27, 2023 shall remain in full force and effect. In the event of a conflict between the provisions of this First Amendment and the original Professional Medical Residency Affiliation Agreement, the provisions of this First Amendment shall govern.
