RESOLUTION TO INITIATE A CONVERSION PROCESS FROM AN INTERAGENCY MERIT SYSTEM (IMS) TO AN APPROVED LOCAL MERIT SYSTEM (ALMS) FOR MERIT SYSTEM SERVICES (MSS)

WHEREAS, the County of Humboldt recognizes that there have been significant recruitment delays since January 1, 2023 for Merit System Services positions administered by the California Department of Human Resources (CalHR); and,

WHEREAS, the County of Humboldt Human Resources department administers recruitments for non-MSS positions in accordance with federal, state, and local Merit-based regulations; and,

WHEREAS, the County of Humboldt is in urgent need of qualified and available candidates for hire to the Department of Health & Human Services (DHHS) and the North Coast Regional Department of Child Support Services (NCRDCSS); and,

WHEREAS, reduced DHHS and NCRDCSS MSS program staff jeopardizes the county's strategic goals of helping residents meet basic needs and lead better lives; and,

WHEREAS, reduced DHHS and NCRDCSS MSS program staff can impact workforce caseload and could potentially cause delays in providing services to the community; and,

WHEREAS, the County of Humboldt desires to streamline all county recruitments through the Merit-based process for recruitment and selection administered by the Human Resources department.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. That the County of Humboldt hereby adopts the resolution to initiate the conversion process from an Interagency Merit System to an Approved Local Merit System for Merit System Services (MSS) positions.
2. That the County of Humboldt hereby authorizes the Director of Human Resources to finalize all documents required by the California Department of Human Resources (CalHR) to advance the Approved Local Merit System (ALMS) County Conversion process.
3. That the County of Humboldt hereby allocates a 1.0 full-time equivalent (FTE) Human Resources Analyst I/II (BU 130, Job Class #0684A/B) position in the Human Resources department.
