

**FIFTH AMENDMENT
MEMORANDUM OF UNDERSTANDING
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
CRESTWOOD BEHAVIORAL HEALTH, INC.
FOR FISCAL YEARS 2011-2012 THROUGH 2029-2030**

This Fifth Amendment to the Memorandum of Understanding dated July 2, 2012, as amended on April 26, 2016, February 19, 2019, May 21, 2020 and May 8, 2023, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Crestwood Behavioral Health, Inc., a Delaware corporation, hereinafter referred to as "CONTRACTOR," is entered into this ____ day of _____, 2026.

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Behavioral Health ("DHHS – Behavioral Health"), desired to provide for the evacuation of patients from COUNTY's inpatient psychiatric health facility in the event of fire or natural disaster or as otherwise ordered by the Fire Marshal or the DHHS – Behavioral Health Director; and

WHEREAS, on July 2, 2012, COUNTY and CONTRACTOR entered into a Memorandum of Understanding regarding the provision of such emergency evacuation services; and

WHEREAS, on April 26, 2016, COUNTY and CONTRACTOR amended the Memorandum of Understanding in order to extend the term thereof and update the contact information set forth therein; and

WHEREAS, on February 19, 2019, COUNTY and CONTRACTOR amended the Memorandum of Understanding in order to modify the execution requirements, and update the contact information, set forth therein; and

WHEREAS, on May 21, 2020, COUNTY and CONTRACTOR amended the Memorandum of Understanding in order to extend the term thereof and modify the execution requirements set forth therein; and

WHEREAS, on May 8, 2023, COUNTY and CONTRACTOR amended the Memorandum of Understanding in order to further extend the term thereof; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend certain provisions of the Memorandum of Understanding in order to further extend the term thereof and update the contact information set forth therein.

NOW THEREFORE, COUNTY and CONTRACTOR hereby mutually agree as follows:

1. Section IX – Term of the Memorandum of Understanding is hereby amended to read as follows:

IX. TERM:

The term of this MOU shall begin on June 1, 2012 and shall remain in full force and effect until June 30, 2030, unless extended by a valid amendment hereto or sooner terminated as set forth herein.

2. The Memorandum of Understanding is hereby amended to delete Exhibit A – Agency Liaisons (“Exhibit A”) and replace it in its entirety with the modified version of Exhibit A that is attached hereto and incorporated herein by reference as if set forth in full. The modified version of Exhibit A attached hereto shall supersede any and all prior versions thereof as of the effective date of this Fifth Amendment.

3. Except as modified herein, the Memorandum of Understanding dated July 2, 2012, as amended on April 26, 2016, February 19, 2019, May 21, 2020 and May 8, 2023, shall remain in full force and effect. In the event of a conflict between the provisions of this Fifth Amendment and the original Memorandum of Understanding, or any prior amendments thereto, the provisions of this Fifth Amendment shall govern.
